Introduction

As part of San Diego Gas & Electric Company (SDG&E)'s solicitation schedule, and to comply with D.18.01.004, SDG&E is requesting Abstracts for the Residential Equity Education & Outreach Program. This is the first stage of the solicitation process that will begin in **March 2023**. This Program will provide underserved residential customers with education and awareness needed to participate in energy efficiency offerings. Classified as an Equity program, this program will have a primary objective of supporting the long-term success of the energy efficiency market by educating Equity residential customers about energy efficiency opportunities. This program will seek to assist SDG&E in achieving various portfolio, segment sector metrics, and drive participation in other Energy Efficiency programs.

Stage 1 is a Request for Abstracts ("RFA"), and Stage 2 is a Request for Proposal(s) ("RFP") for organizations selected from Stage 1. The RFA will enable bidders ("Bidder" or "Contractor") to provide sufficient information for SDG&E to narrow down the selection to proceed to Stage 2, at which time we will issue a full RFP. It is not intended that Bidders prepare a detailed Abstract in Stage 1. Instead, it is important that Bidders use the Abstract to provide enough information about the design, implementation and management of a proposed program, targeted market and customer segments, and overall program design and goals.

Purpose and Objectives

The purpose of this RFA is to evaluate Abstracts for program design and implementation services for the Residential Equity Education & Outreach Program.

- Experience and Capability, including SBE/ DBE Outreach

If the Abstract(s) is successful, the bidder will be asked to submit a proposal at a later date that will include detailed information regarding information provided in the Abstract along with additional information to further validate the Proposal.
